I have entered in the field rentals for Shakerag Park Baseball Field and Newtown Baseball Field #2.

For Shakerag Field, I've rented you the field from 8:30am – 2:30pm.

For Newtown Baseball Field 2, I have rented you the field from 8:30am – 11:30am. Our youth sports league needs use of the field at 12noon on Sundays.

Ocee Park fields are currently not available for rent. As I mentioned, we are in the process of installing synthetic turf infields on these fields. As soon as the turf project is complete, I can confirm with you availability to rent. This project just got started and we are completing fields 1 and 2 first.....with fields 3 and 4 completed last. Weather may delay the project, so I cannot give you a confident start date for Sunday rentals. Please know that there is a chance that the rental rate for these new TURF fields may increase. But that won't be official unless City Council approves a new turf baseball field rental rate.

I have emailed you a statement through REC1 for the Shakerag and Newtown Baseball Field rentals. Please fill out the attached credit card form and scan/email back to me and I can begin to charge you at the beginning of each month for upcoming month. As in the past, if we get rained out and you don't use a field(s), I can credit the rental rate back on the credit card.
